

# Expression of Interest for Work Stream 2 Topics

## Introduction

The CCWG-Accountability (CCWG-ACCT) is seeking volunteers to participate in sub-groups for each of the nine identified Work Stream 2 topics. This Expression of Interest is designed to provide an open, transparent way to indicate your interest in participating in this sub-group work.

There are two ways to volunteer:

1. As an **active participant** who wishes to engage in the day-to-day discussions of the particular topic. Each active participant is expected to spend at least 3-5 hours per week on sub-group work and will have posting rights to the mailing list.
2. As an **observer** who wishes to follow the topic discussion but not actively participate at the sub-group level. Observers are not expected to spend time on sub-group work and will not have posting rights to the mailing list.

Each sub-group will be responsible for developing the framework for discussion, putting forward suggestions and proposing solutions to the full CCWG-ACCT on its respective topic. While the majority of work will take place at the sub-group level, all decisions about utilizing outputs of the sub-group will be made during Plenary calls by the full CCWG-ACCT.

This sub-group system for organizing Work Stream 2 has been implemented to allow work to take place effectively and within reasonable timeframes. Sub-groups are expected to be small, coherent groups with diverse participation from across the CCWG-ACCT. The sub-groups will develop recommendations for each topic, and their work will later be considered, revised and shaped by the full CCWG-ACCT.

The co-Chairs will assess the list of volunteers for each topic area and try to encourage balance of representation from across the CCWG-ACCT to determine the makeup of each sub-group. From the list of volunteers, the co-Chairs will nominate lead drafters or rapporteurs for each sub-group, and the full CCWG-ACCT will discuss and finalize the makeup of sub-group's volunteers.

**You do not have to volunteer for a sub-group to influence the result of the topic.**

**Participation in the full CCWG Plenary discussions will allow every member or participant the opportunity to provide input on any given topic. Your time commitment is up to you.**
