- Better utilization of ICANN staff to explain reports, policies and initiatives to group
- Distributing leadership opportunities across the Business Constituency
- Improving transparency and input on Business Constituency budget
- Amending bylaws to include term limits and requiring elections for positions in which there are more interested than slots allowed

I will follow the policy and other positions of the Business Constituency and recuse myself and be clear about my affiliation when I cannot.

Lastly, I will fully participate in the work of the position nominated for, which requires significant time commitment to fulfill the duties of the position on behalf of Business Constituency members.

### <u>Steve DelBianco, NetChoice – Standing for Vice Chair for Policy Coordination</u>

BC members,

After serving 4 years as our first vice chair for policy coordination, I'm seeking reelection for 2014.

In the past 4 years, I believe we have raised members' <u>awareness</u> and <u>participation</u> in policy matters. One tool for raising <u>awareness</u> is our regular policy calendar. Another is ad-hoc emails and calls where I try to succinctly describe a relevant issue with links to external docs and prior BC positions.

Raising <u>participation</u> levels remains a challenge, since members' time is limited because of other obligations. Still, we published a record number (22) of positions/statements on key policy issues during 2013. And we made significant policy impacts outside of the public comment process as well.

In this role I also support our BC representatives on GNSO Council. As they are directly engaged in policy debates and voting, our Councilors deserve timely and specific guidance from the BC membership on relevant issues.

In the year ahead, the BC must press general business interests at ICANN. 2014 is the year where ICANN will delegate over 1000 new gTLDs, including single-registrant 'brand' TLDs for several BC member companies. As new gTLDs are launched we'll quickly assess the effectiveness of rights protection mechanisms and Public Interest Commitments by gTLD operators.

Later in 2014, ICANN will begin the Affirmation review on whether the gTLD expansion has promoted Consumer Trust, Consumer Choice, and Competition. I served on both the first and now the second working group to develop definitions and metrics for that review.

Beyond new gTLDs, ICANN has placed itself in the center of a debate over the roles of governments and intergovernmental organizations. I believe the BC should defend ICANN's multi-stakeholder model while also pressing ICANN leadership to refrain from top-down strategic initiatives that would take ICANN beyond its narrow technical mandate.

If the membership returns me to this post, I would work to improve the breadth of participation by BC members. We have recently seen some new volunteers step-up to draft BC positions. I hope my support and coordination has helped these volunteers have a positive experience.

BC members may have additional ideas on how the vice chair for policy coordination could be more effective. If re-elected, I look forward to hearing those ideas.
