

# Expression of Interest for Work Stream 2 Topics

## Introduction

This document is designed to seek volunteers for each of the nine Work Stream 2 topics the CCWG-ACCT is going to work on. It provides an open, transparent way to offer to volunteer in two categories: those who wish to actively work on a particular topic, and those who wish to observe topic discussion but not actively participate at the sub-group level.

**You do not have to volunteer for all, or even any, topic, to have a real say. You can have your say and your input in the full CCWG, in a sub-group on a topic, or both. Your time commitment is up to you.**

All decisions about the working methods, and decisions on how to use the outputs of any of the sub-groups, are in the hands of the full CCWG-ACCT. No matter what is discussed or agreed on a topic by a sub-group, it is the full CCWG-ACCT that makes all the decisions. This is important because it is not possible to have large, slow sub-groups for each topic if the work is to be done effectively and within reasonable timeframes. These are expected to be small, coherent groups with limited but diverse participation from across the CCWG-ACCT to do the drafting work the CCWG-ACCT will later consider, revise and shape. Nothing more.

The co-chairs will assess the volunteers for each topic area and try to encourage balance of representation from the CCWG-ACCT across each, and will nominate lead drafters or rapporteurs for each group in discussion with the volunteers, for the CCWG-ACCT to discuss and decide on.
