2, 5 or 15%, none of these numbers are yet based on any specific measurement of expected procedures and requirements, which have not even yet been defined.

Xavier Calvez:One of the factors that will significantly impact costs, which is not usually considered in any standard percentage, is the cost inherent to supporting a multistakeholder process: whether it is to organize some community communication on the overall process of the auction proceeds, or to support transparency and accountability mechanisms, these activities are rarely encountered elsewhere but are prevalent at ICANN and are very resource consuming. That will significantly impact the costs incurred for the program. If you take an illustration that the Drafting Team early on and now this CCWG AP have been working on the topic for 2 years, with ICANN's support, the costs is already significant and we have not even started implementing anything.

Xavier Calvez:It is challenging at this stage to even assign 3 or 10% since we do not know what costs will be driven by the choice of the mechanisms, nor what costs will be incurred irrespective of which mechanism is chosen.

Marilyn Cade: Apologies to be delayed in joining. No comments at this time until I catch up. Marilyn Erika Mann: Good to have you with us Marilyn!

Vanda Scartezini:take a look at the baord letter Marilyn

Vanda Scartezini:we are discussing some flavors from the letter adn cost assocaited

Tony Harris 2:I think verifications shoula always be done

Judith Hellerstein:HI Erika that seems to be a good approach

Marika Konings: Sounds still ok on this end (on the phone bridge)

Xavier Calvez:What Becky is illustrating with the topic of tranches is one of the operational consequence of the board's fiduciary duty that the funds are used within mission and effectively: releasing funds in tranches to a given recipient allows to establish accountability mechanisms for that recipient to demonstrate that the funds are appropriately used. The other tranche topic is, as an example, to provide X million of dollars for allocation during a given year, which also allows to control the amount of effort required for evaluation and disbursement, allowing to minimize risks of erros or issues.

Marika Konings:Yes - I've captured it as part of the notes

Alan Greenberg: "Infrastructure projects of \$100-150m"?? I would not think that is what we are looking at.!

Vanda Scartezini:yes I can also agree with Erika on this regard

Marilyn Cade: I am not sure that we can commit to building infrastructure projects, so need to know more what you meant.

Hadia Elminiawi:sounds good Xavier and Becky

Marilyn Cade: I would hve thought that an Infrastructure project would be an exception if it is more than a couple of million.

Tony Harris 2:Launching a large amount of small grants can cause a huge amount of applicants, a token application fee should be charged to filter gamers

Vanda Scartezini:yes Tony.

Mary Uduma: @ Tony Why application fee for a grant?

Marilyn Cade: I am very concerned that we keep avoiding discussing and updating the community, and I have not been online today, as I am traveling. This is beginning to look like we are avoiding engagement with the broader community, and that worries me a lot.

Marilyn Cade:Marika, Ching, Erika -- there is almost no spare time within the schedules of the participants to add in briefings for numerous sepaerate groups. I am not sure that is very feasible. Can I hear more about why we are not doing the HIG/and how we will still make this a briefing for the broader community?

Marika Konings:@Marilyn - all CCWG sessions have been open to date and regular updates have been sent to all chartering organizations

Tony Harris 2:Otherwise you may get a lot of people trying their luck to get some money. They can be blocked by an evaluator but that can be a lot of work involved plus cost
