2017 Year in Review

The year 2017 was an inaugural for Internet PNG Clique (iPNGC) as an ICANN ALS (Internet Corporation for Assigned Names and Numbers, At-Large Structure). An ALS is an affiliation with ICANN that will accredit an organization to contribute in ICANN Policy Development processes.

The board did not do much for the society in 2017 to engage internet users in programs and events locally; however we have had few highlights that reflected the benefits of knowledge capacity building in the community. This newsletter briefly outlines the highlights of 2017 and an overview of the society.

1. iPNGC an ICANN ALS

- iPNGC was accepted as an ALS on 17 of January 2017
- First ALS in PNG and only the 5th
 ALS in the Pacific outside Australia
 and New Zealand.

2. Capacity Building Highlights

 ICANN Staff Visit to Unitech – In February 2017, I CANN Staff Mr. Save Vocea visited Unitech to meet with .pg management. The iPNGC board coordinated the visit and made arrangement with the University administration so Save had the opportunity to speak to University staff and students on ICANN's Multistakeholder Model.

- ALS Orientation June 2017, iPNGC attended APRALO (Asia Pacific Regional At-Large Structure) Monthly Call. We briefly introduced iPNGC to APRALO Leaders and members. 5 iPNGC members attended the online call.
- ICANN Fellowships Number of ICANN fellows from PNG have increased in the last 3 years when iPNGC began awareness. In 2015, Priscilla Kevin attended ICANN54 in Dublin. In 2016 I (Stanley Osao) attended ICANN56 in Helsinki, Matilda Pamao & Kasek Galgal attended ICANN57 in Hyderabad. In 2017, Violet Ningakun attended ICANN58 in Copenhagen, Priscilla Kevin, Kasek Galgal & myself attended ICANN59 in Johannesburg; while at ICANN60 in Abu Dhabi, Decka David & Patrick Nolye were selected.

Internet PNG Clique (iPNGC) began in 2011 as a national network of internet users in PNG with inclusion of some members from Pacific region. It began with mainly discussion of internet governance issues in the country; and also create awareness on challenges and opportunities created by internet.

On October 2016, iPNGC was officially recognized by National Government of Papua New Guinea (PNG) through Investment Promotion Authority (IPA) as a legal entity and registered not for profit organization.

On January 16 2017, iPNGC was officially accredited as an ALS under APRALO by ICANN. In the first year of involvement as an ICANN ALS, iPNGC engaged its members and local community through knowledge capacity building and information sharing.
