Direct experience and knowledge of the IANA naming function	As CEO of CIRA, the ccTLD for .ca, Canada, I have participated in many name server changes for CIRA's DNS since becoming CEO in 2008. In addition, I have considerable direct experience with the IANA naming function as a result of being chair of the ccNSO from 2013 to 2016, as co-chair of the CWG IANA Stewardship Transition Charter Drafting Team and as a CWG 'participant' throughout the whole IANA transition process.

I also served as co-chair of the CWG Drafting Team on the IANA Stewardship Transition and followed the work of the CWG very closely, both as a CWG 'participant' as well as chair of the ccNSO during the bulk of the IANA transition discussions. As such, I am very familiar with the role the CSC needs to play in the post IANA transition environment, both from the overall governance perspective as well as from the perspective of a ccTLD manager. My role as a member of the High Level Panel on Global Internet Cooperation and Governance Mechanisms has helped me to understand the role of the ICANN SO/AC community in the larger Internet governance ecosystem.

Commits to actively participate in the activities of the CSC on an on-going basis	As mentioned above, because of my involvement in the IANA transition process, I well understand the role the CSC needs to play in the post IANA transition environment. It needs to quickly establish

	itself in its role as overseer of the performance of PTI in its discharge of the IANA functions. The registry community, and the ICANN community as a whole, needs to be assured of the continued strong performance of the IANA function for the direct customers of the naming services. The first responsibility of the CSC will be to establish its own internal operational procedures and to engage other members in its ecosystem and forge the necessary relationships that will characterize its successful operation. I commit to undertaking these responsibilities.
Employed or have active backing by a ccTLD Manager	It is part of the ethos of my employer, CIRA, a 'not-for-profit' company, to contribute and support the Internet governance community in general and the ccTLD community specifically. Further, from a practical perspective, since IANA is a primary supplier to my organization, it is incumbent upon me to ensure that the IANA transition delivers the best possible outcome for the TLD community and that the initial CSC creates the environment and processes that can deliver that outcome.

III. Understanding of Purpose of CSC

The purpose of the CSC is to ensure continued satisfactory performance of the IANA function, in a post NTIA environment, for the direct customers of the naming services, which primarily include ccTLD and gTLDS operators, but also include root server operators and other nonroot zone functions. This will be accomplished through regular monitoring of IANA performance measured against clearly defined Service Level Agreements.

IV. Time Commitment

CSC members and liaisons are expected to participate in monthly meetings. Members and liaisons must attend a minimum of nine meetings in a one-year period, and if less meetings at least 75 % of the meetings in case less than the anticipated monthly meetings are held). A CSC member is also expected not be absent for more than two consecutive meetings without sufficient cause. Outside of the monthly meetings, members and liaisons may also be asked to participate in other CSC processes.
