IANA IPR LICENSE AGREEMENT

[FOR IANA [INSERT] SERVICES]

This License Agreement ("<u>Agreement</u>") is <u>dated_entered into</u> as of this ____ day of _____, 2016, (<u>"Effective Date"</u>), by and <u>amongbetween</u> the IETF Trust, a Virginia common law trust, (<u>"Licensor</u>") and the Internet Corporation for Assigned Names and Numbers (<u>"ICANN</u>"), a California nonprofit public benefit corporation (<u>"Licensee</u>"). The <u>"Effective Date" of this</u> Agreement shall be the effective date of the IANA Intellectual Property Assignment Agreement between Licensor and Licensee dated as of the date hereof. Licensor and Licensee may each be referred to herein as a <u>"Party</u>," and collectively as the <u>"Parties</u>."

ARTICLE 1 DEFINITIONS

- 1.1 <u>AAA</u>: The American Arbitration Association.
- 1.2 <u>Affiliate</u>: With respect to a party hereto, a corporation or business entity that, directly or indirectly, is controlled by, controls, or is under common control with such party, together with all officers, members, managers and directors of such party, corporation or business entity. For this purpose, the word "control" shall mean direct or indirect ownership of fifty percent (50%) or more of the equity or voting shares or interest of such corporation or business entity having the right to vote for the election of directors, or the power to appoint a majority of the board of directors or other governing body or otherwise to direct the management and policies of such corporation or business entities, whether by contract or otherwise. For the avoidance of doubt, (i) the Internet Society, a District of Columbia non-profit corporation, is not an Affiliate of the Licenser, and (ii) [PTI]₅₂ a California nonprofit public benefit corporation, is an Affiliate of the Licensee.

ARTICLE 2 TRADEMARK LICENSES

2.1 <u>Grant of Licenses</u>. As of the Effective Date, Licensor hereby grants Licensee, and Licensee hereby accepts, a worldwide, exclusive, royalty-free, fully-paid right and license (including a right to sublicense in accordance with Section <u>1.19.7</u> below) to use, display and reproduce the Licensed Marks in connection with the provision and marketing of goods and services in connection with (a)_the IANA Names Services, (b) the IANA Numbers Services and (c) the IANA Protocol Parameter Services.[1]. For the avoidance of doubt, three independent and separately terminable licenses are granted hereunder with respectthis license includes the right of Licensee to the three categories of IANA Services set forthuse the Licensed Marks to describe its performance of the IANA Services on its web site, publications and elsewhere, but this license does not authorize the use of the Licensed Marks in clauses (a) (c) above.connection with any other services.

2.2 <u>Quality Requirements</u>. Licensee agrees that all IANA Services offered under the Licensed Marks shall be of a consistent quality at least as high as the quality of comparable services offered by ICANN immediately prior to the Effective Date and shall comply with <u>any additional the</u> service quality requirements that the Parties mutually agree upon throughout<u>contained in</u> the <u>Term</u>, which shall be incorporated into and made a part of this<u>Service</u> Agreement. Licensor and Licensee agree that <u>all</u> quality monitoring responsibilities are reserved to each Operationalhereunder shall be conducted by the Relevant Community, which shall report any failure of the IANA Services to comply with respect the relevant quality standards to the services offered to or for the benefit of that Operational Community. Licensor.

2.3 <u>Usage Requirements</u>. All uses of the Licensed Marks shall be in strict accordance with <u>ICANN's</u> uses of the Licensed Marks by ICANN-immediately prior to the Effective Date, and all

uses substantially similar thereto ("<u>Style Requirements</u>"). Licensor and Licensee shall each have the right to propose modifications to such <u>use of the Licensed MarksStyle Requirements</u>, subject to the other Party's prior written approval, not to be unreasonably withheld, <u>conditioned</u> or delayed, <u>upon [60 days] prior written notice to the other Party.</u> In the event of such a change, Licensee shall be permitted to deplete its existing inventory of printed marketing material complying with the immediately prior version of the <u>usageStyle</u> Requirements for up to <u>one yearthree (3) months</u> following the effectiveness of such change. Thereafter all such obsolete materials shall be destroyed, other than copies kept for archival, informational, historical, record-keeping or legal purposes. The current version of the Style Requirements is attached hereto as Exhibit D. <u>Licensee</u> shall use commercially reasonable efforts to ensure that all digital displays are changed within[2] [45 days] to reflect any new Style Requirements.

ARTICLE 3 DOMAIN LICENSES

3.1 <u>Grant of License</u>. As of the Effective Date, Licensor hereby grants Licensee, and Licensee hereby accepts, a worldwide, exclusive, royalty-free, <u>fully-paid</u> right and license <u>(including a right to sublicense in accordance with Section 9.7 below)</u> to use the IANA Domains and to create subdomains thereunder, subject to Section []3.3 below, solely in connection with the provision and marketing of (a) the IANA Names Services, (b) the IANA Numbers Services and (c) the IANA Protocol Parameter Services. For the avoidance of doubt, three independent and separately terminable licenses are granted hereunder with respect to the three categories of IANA Services set forth in clauses (a)-(c) above.

3.2 <u>Technical Contact</u>. Licensor hereby designates Licensee as the technical contact for the IANA Domains. Licensee acknowledges that if all of the licenses granted hereunder with respect to the IANA Services are terminated (e.g., IANA Names Services, IANA Numbers Services and IANA Protocol Parameter Services), then Licensor may designate one or more third parties during the term of this Agreement. Licensee's obligations as the technical contacts for one or more IANA Domains. In the event one or more but not all of the licenses granted hereunder are terminated, Licensee shall remain the technical contact for the IANA Domains, but shall be obligated to cooperate with any third party that is party to a valid written agreement to perform one or more IANA Services and is party to a license agreement with the IETF Trust granting such third party a license to use the IANA Domains and to create subdomains thereunder in connection with the provision of such IANA Services are set forth in Exhibit E.

3.3 <u>Subdomains</u>. All subdomains of the IANA Domains existing as of the Effective Date are approved for use by Licensee in connection with the licenses granted hereunder. Licensee shall <u>submit all proposed newonly create</u> subdomains when necessary to fulfill its obligations to perform IANA Services under the IANA Domains to Service Agreement, Licensee will notify Licensor for approval in consultation withif there is an intended usage of a Licensed Mark within that subdomain (excluding the CCG prior to their registration or use, such approval not to be unreasonably withheld, conditioned or delayed. <u>domain itself</u>).

ARTICLE 4 OWNERSHIP

4.1 <u>Goodwill</u>. As of the Effective Date, Licensee acknowledges that Licensor is the owner of the Licensed Marks and all goodwill therein and arising from their use, and that nothing in this

Agreement or otherwise grants Licensee any ownership right in or to any such Licensed Marks. Licensee hereby assigns to Licensor all business goodwill in the Licensed Marks that arises from use of the Licensed Marks.

4.2 <u>Restrictions</u>. From and after the Effective Date, Licensee agrees that it shall not, (a) without the prior written approval of the Licensor, not to be unreasonably withheld, conditioned or delayed, register or reserve any name, mark, logo, word or design that contains, is identical to or is confusingly similar to any Licensed Marks as a trademark, service mark, certification mark, trade name, domain name or search term in any jurisdiction in the world, (b) challenge Licensor's ownership of or the validity of the Licensed Marks, any application for registration or registration thereof or any rights of Licensor therein; (c) knowingly do any act that is intended to invalidate or impair any Licensed Marks; or (d) use, suffer or permit the use of any Licensed Marks in any manner that is intended to devalue, injure, demean or dilute the goodwill or reputation of Licensor or the Licensed Marks- or which is outside the scope of the licenses granted pursuant to Section 2.1. For the avoidance of doubt, no trademarks owned by ICANN immediately after the Effective Date, as-set forth on Exhibit C, are shall be deemed to be confusingly similar to the Licensed Marks.

4.3 <u>Policing and Enforcement</u>.

<u>a.</u> From and after the Effective Date, <u>each Party</u> shall undertake <u>all</u>-commercially reasonable efforts, <u>consistent with its past practice in relation to other intellectual property</u>, to police third party uses, applications and registrations that might constitute infringement or dilution of the IANA Intellectual Property. Each Party shall use reasonable efforts to notify the other Party-and the <u>CCG</u> of any infringement or threatened infringement of the IANA Intellectual Property of which it becomes aware.

b. Licensor shall, after consultation with the Relevant Operational CommunitiesCommunity and the CCG, have the solefirst right but not the obligation to take any action to bring suit to stop such infringement or otherwise enforce Licensor's rights and Licensee shall, at Licensor's expense, cooperate with Licensor in any such action. All decisions regarding enforcement shall be approved by the CCG or by the relevant CCG Representatives as provided in the Community Agreement. If Licensor initiates such an enforcement action hereunder, it shall have the exclusive right to employ counsel of its own selection and to direct and control the litigation or any settlement thereof and shall be entitled to retain all amounts awarded as damages in connection therewith after the expenses of Licensee, CCG, the Operational Communities and Licensor are reimbursed on a pro rata basis. In any such action, Licensee shall, at its own expense (subject to reimbursement out of damages awarded pursuant to the preceding sentence), have the right to noncontrolling participation through counsel of its own selection.

c. If Licensor elects not to enforce its rights or to take <u>other</u> action to stop such infringement, including but not limited to proposing or entering into negotiations, within thirty (30sixty (60) days offollowing written notification of such infringement to Licensor by Licensee, then Licensee may, after consultation with the Relevant Operational CommunitiesCommunity, take any action to stop such infringement or otherwise enforce its and Licensor's rights, <u>subject to</u> <u>Licensor's prior written approval not to be unreasonably withheld, delayed or conditioned</u>. If Licensee initiates such an enforcement action hereunder, it shall employ counsel of its own selection and at its own expense and shall direct and control the litigation or any settlement thereof, which settlement shall be subject in each case to the prior written approval of the CCG or relevant CCG Representatives thatLicensor, which approval shall not be unreasonably withheld, conditioned or delayed, and shall be entitled to retain all amounts awarded as damages in connection therewith after the expenses of Licensee, PTIits sublicensee, CCG, the Operational Communities and Licensor are reimbursed on a pro rata basis. In any such action, Licensor shall, at its own expense (subject to reimbursement out of damages awarded pursuant to the preceding sentence), have the right to non-controlling participation through counsel of its own selection. At Licensee's request, Licensor shall assist reasonably in such enforcement action, and Licensor acknowledges that it may be a necessary party to any action brought by Licensee arising from enforcement of such rights, and, if necessary, Licensor shall participate in such action.

4.4 Maintenance. In the event that Licensee requests that Licensor register one or more Licensed Marks in a jurisdiction in which such marks are not then registered, Licensor shall consider such request in good faith in consultation with the Relevant Community. In the event that Licensor agrees to register such Licensed Mark in such jurisdiction, Licensor may require that Licensee reimburse it for its out-of-pocket expenses associated with such registration, including filing fees, translation charges and legal fees, and associated maintenance fees. Except with respect to such registrations requested by Licensee, Licensor shall, at its sole cost and expense, maintain all registrations for the Licensed Marks.

ARTICLE 5 INDEMNIFICATION

5.1 <u>By Licensee</u>. Licensee will indemnify, defend and hold harmless Licensor and its Affiliates, and their respective employees and trustees ("Trust Indemnitees") from and against any and all Third Party Claims (as defined below) and associated Liabilities, losses, costs, expenses and damages ("Liability") to the extent arising directly or indirectly from (a) any material breach by Licensee of the terms of this Agreement, or (b) Licensee's or its sublicensees' sublicensee's use of the IANA Intellectual Property and its sublicensees' use of the IANA Intellectual Property, following the Effective Date and during the term of this Agreement, other than claims that would give rise to an indemnification obligation by Licensor pursuant to Section 5.2 below.

5.2 <u>By Licensor</u>. Licensor will indemnify, defend and hold harmless Licensee and its Affiliates, and their respective directors, officers and employees ("<u>Licensee Indemnitees</u>") from and against any and all Third Party Claims and associated Liabilities to the extent arising directly or indirectly from elaims that Licensee's or its sublicensee's use of the IANA Intellectual Property consistent with this Agreement following the Effective Date and during the term of this Agreement infringes or dilutes the rights of any third party.any material breach by Licensor of the terms of this Agreement.

5.3 <u>Indemnification Procedure</u>.

a. A Party seeking indemnification hereunder ("Indemnified Party") will give prompt written notice (an "Indemnification Notice") to the Party from which indemnification is sought ("Indemnifying Party") of the assertion of any third party claim, or the commencement of any third party suit, action or proceeding ("Third Party Claim") in respect of which indemnity may be sought under Section 5.1 or 5.2, and will provide the Indemnifying Party such information with respect thereto that the Indemnifying Party may reasonably request. The failure to promptly notify the Indemnifying Party shall not relieve the Indemnifying Party of its obligations hereunder, except to the extent such failure shall have prejudiced the Indemnifying Party.

b. The Indemnifying Party shall manage and control the defense of any Third Party Claim as to which indemnification is sought hereunder at its sole expense using counsel of its selection, subject to the reasonable prior approval of the Indemnified Party. The Indemnifying Party shall obtain the prior written consent of the Indemnified Party (which shall not be unreasonably withheld, conditioned or delayed) before entering into any settlement of such Third Party Claim if the settlement does not release the Indemnified Party from all Liabilities with respect to such Third Party Claim or the settlement imposes injunctive or other equitable relief against the Indemnified Party. The Indemnified Party shall be entitled to participate in the defense of such Third Party Claim and to employ separate counsel of its choice for such purpose at its own expense. Each Party shall cooperate in the defense or prosecution of any Third Party Claim and shall furnish or cause to be furnished such records, information and testimony, and attend such conferences, discovery proceedings, hearings, trials or appeals, as may be reasonably requested in connection therewith.

ARTICLE 6 TERM AND TERMINATION

6.1 <u>Term</u>. This Agreement shall remain in effect from the Effective Date until it is terminated in accordance with the terms hereof.

6.2 <u>Termination by Licensee</u>. Licensee may terminate this Agreement-or any license granted hereunder upon sixty (60) days prior written notice to Licensor.

6.3 <u>Termination of License(s) for Change of Service Provider[3]</u>. Licensee acknowledges that the licenses granted hereunder are necessary for provision of the IANA Services, and that Licensee is required to perform (directly or indirectly through subcontractors to Licensee) the IANA Services under a number of separate agreements with the Operational Communities.the Service Agreement. [*The following provision applicable to numbers and protocol licenses:* Accordingly, may terminate one or more of the licenses granted hereunder in respect of the IANA Services as follows:

(a) If the RIRs (as defined in the Service Level Agreement for the IANA Numbering Services, dated 29 June 2016, among Relevant Community certifies in writing to Licensor and the RIRs (as supplemented and amended from time to time, the "<u>RIR SLA</u>")), acting collectively and unanimously, certify in writing to the IETF Trust(with a copy to Licensee) that (i) such the Service Level Agreement or any successor agreement between ICANN and the RIRs, pursuant to which ICANN performs the IANA Numbers Services, has validly expired or has been validly terminated in each case in accordance with its terms, and (ii) ICANNLicensee and its Affiliates are no longer authorized by the <u>RIRsRelevant Community</u> to perform or oversee the performance of the [IANA <u>NumbersNumber</u> Services, IANA Protocol Services] Licensor shall have the right to terminate the license in respect of the IANA Numbers Servicesthis Agreement immediately upon written notice to Licensee. (b) If the Internet Engineering Task Force ("<u>IETF</u>").] [*The following provision is* applicable to the names license: Accordingly, if the Names Community certifies in writing to the IETF Trust that (i) the memorandum of understanding or any successor agreement between ICANN and the IETF (as supplemented and amended from time to time, the "<u>IETF MOU</u>"), pursuant to which ICANN performs the IANA Protocol Services, has validly expired or has been validly terminated in each case in accordance with its terms, and (ii) ICANN and its Affiliates are no longer authorized by the IETF to perform or oversee the performance of the IANA Protocol Services, Licensor shall have the right to terminate the license in respect of the IANA Protocol Services immediately upon written notice to Licensee.

(c) If ICANN certifies in writing to the IETF Trust(with a copy to Licensee) that (i) an SCWG Recommendation (as defined in ICANN's Bylaws), providing that ICANNLicensee and its Affiliates and/or sublicensees (as applicable) shall cease performing and overseeing the performance of the IANA Names Services in all respects, has received each of the approvals required under ICANN's Bylaws (and such approval has not been rejected by the Empowered Community, a nonprofit association formed under the laws of the State of California, as set forth in ICANN's Bylaws), and (ii) ICANNa third party has been retained and its Affiliates thereafter cease performing and overseeing the performance is contractually obligated to perform the IANA Names Services immediately following the terminate the license in respect of the IANA Names Services immediately upon written notice to Licensee; [4].]

6.54 <u>Termination for Breach</u>. Either Party may terminate this Agreement following a material, <u>uncured breach of Agreement</u>. this Agreement shall automatically terminate, without any further action of by the Parties, upon the valid termination of all licenses granted other Party pursuant to ICANN and its Affiliates under this Agreement. the procedures set forth in Article 7.

6.65 <u>No Termination for Bankruptcy</u>. For the avoidance of doubt, Licensor is not entitled to terminate the agreement solely on account of an insolvency or bankruptcy event by Licensee or any sublicensee.

6.6 <u>Effects of Termination</u>.

a. Termination of this Agreement or any license hereunder shall be without prejudice to any right to sue for damages for any antecedent breach of this Agreement.

b. Immediately upon the termination of this Agreement-or any trademark license hereunder, Licensee shall makeuse reasonable efforts to remove any and all Licensed Marks from all displays, materials, web sites and other visible locations, and cease to use such Licensed Marks in any business or other activity, subject to any transition period provided for in the RIR-SLA, the IETF MOU or ICANN's Bylaws, as applicable or otherwise agreed between Licensor, the Operational Communities and Licensee. Service Agreement or otherwise agreed between Licensor (after consultation with the Relevant Community) and Licensee. For the avoidance of doubt, such termination shall not limit Licensee's continuing right to use the Licensed Marks under any separate license agreement between Licensor and Licensee with respect to different IANA Services provided to another Operational Community, and Licensee shall not be in breach of its obligation to remove or discontinue use of the Licensed Marks to the extent that it is permitted to do so under such separate agreement.

c. Immediately upon the termination of this Agreement, Licensee shall, at its expense, transfer technical control over the relevant domain name(s) and subdomain(s) to Licensor or to its successor licensee(s) for the terminatedIANA Services, subject to any transition period provided for in the RIR SLA, the IETF MOU or ICANN's Bylaws, as applicable,Service Agreement or otherwise agreed between Licensor, (after consultation with the Relevant Community) and Licensee. Notwithstanding the foregoing, in the event that Licensee or its sublicensee continues to provide services to a different Operational Communities and LicenseeCommunity under a license of the IANA Intellectual Property from Licensor, then the Parties, in consultation with the Relevant Community, shall mutually agree upon a reasonable approach to allow any replacement provider of IANA Services to operate under one or more subdomains [5] of the IANA Domains at no additional charge[6].

d. The provisions of Articles 4, 5, 6, 7, 8 and 9 of this Agreement shall survive any termination hereof in accordance with their terms.

ARTICLE 7 REMEDIES FOR BREACH ESCALATION PROCEDURES

7.1 <u>Notice</u>. If either Party to this Agreement (the "<u>Alleging Party</u>") determines that the other Party (the "<u>Breaching Party</u>")² has materially breach this Agreement, then the Alleging Party shall provide the written notification of such alleged breach to the Breaching Party, which notification shall specify in reasonable detail the facts and circumstances of such alleged breach. The Licensee shall obtain the approval of the CCG prior to providing a breach notification.³

7.2 <u>Cure Period</u>. Following <u>the</u> Alleging Party's notification to the Breaching Party of such alleged breach <u>pursuant to Section 7.1</u>, the Breaching Party shall have a period of sixty (60) days to cure such breach or, if such breach cannot reasonably be cured within sixty (60) days, within a reasonableor such longer period for such cure to beas agreed betweenby the Alleging Party and the Breaching Party.("Cure Period") to cure such breach.

7.3 <u>Consultation Period</u>—; If <u>such the</u> alleged breach is not cured to Alleging Party's reasonable satisfaction within <u>such period the Cure Period</u>, or if such breach is not susceptible of cure, then a ninety (90) day executive consultation period ("<u>Consultation Period</u>") shall begin. During such period, a senior officer of (which shall be, as applicable, the chief executive officer or another senior <u>officeofficer</u> of Licensee and the Chair of the Licensor) <u>of</u> each of the Alleging Party and the Breaching Party, and, in their discretion, CCG Representatives for the Operational Communities

shall meet in person at a mutually agreed location, at least once, and by other telephone or electronic means as required, to use their best efforts in good faith to find a mutually-acceptable means for addressing the alleged breach. The CCG Representatives for the Relevant Community are entitled to participate in such consultations. Each Party shall bear its own expenses in connection with such consultations. If requested by a Party, a third-party mediator may be utilized in order to facilitate discussion and settlement of the dispute, the expenses of which shall be shared equally by the Parties. If a mediator has been utilized, the Consultation Period may be extended by an additional thirty (30) days.

7.4 Mediation Arbitration. If by the Parties fail to reach agreement within ten (10) days following the end of the Consultation Period, the Parties have not reached an amicable solution and (the "Arbitration Initiation Date") and the Breaching Party has not cured such alleged breach to the Alleging Party's reasonable satisfaction, then the Parties agree first the Alleging Party and the Breaching Party shall be entitled to try in good faithinitiate binding arbitration to settle theresolve such dispute-by submitting to voluntary mediation administered by. If the Parties fail to reach agreement within ten (10) days following the end of such mediation and the Breaching Party has not cured such alleged breach to the Alleging Party's reasonable satisfaction, the Alleging Party shall be entitled to initiate a legal proceeding in a state or federal court sitting in the Central District of California The arbitrator shall be authorized to determine questions of fact and law, to award monetary damages and to order specific performance, provided that the sole questions to be determined by the arbitrator is whether the Breaching Party has in fact materially breached any provision of this Agreement, and, in connection therewith, may seek monetary damages and/or specific performance of the Breaching Party's obligations under this Agreement. Such monetary damages and specific performance of doubt, the Breaching Party has the right to challenge any such alleged breach in the state and federal courts sitting in the Central District of the terms of this Agreement and whether any failure of the

Alleging Party to accept any proposed or actual cure of such breach was reasonable. For avoidance of doubt, the arbitrator is precluded from making any determination as to the sufficiency of Licensee or its Affiliate's provision of IANA Services. The results of the arbitration shall be final and binding, and shall be supported by a reasoned opinion. The arbitral award may be enforced in any court of competent jurisdiction. Upon mutual agreement of the Parties, the consultation, mediation and arbitration processes of any Alleged Breach, may be combined with any such processes initiated under another Community License Agreement.

7.5 Termination for Breach. In the event that the arbitration referred to in Section 7.4 results in a finding that the Breaching Party materially breached this Agreement and such breach was not cured to the reasonable satisfaction of the Alleging Party (as determined by the arbitrator) prior to the date of the decision of the arbitrator pursuant to Section 7.4, then the Alleging Party shall have the right to terminate this Agreement upon written notice to Breaching Party. Notwithstanding the foregoing, the breach constituted a failure by Licensee to meet the service quality requirements for the applicable IANA Services as described in Section 2.2, Licensor's sole and exclusive remedies hereunder shall be limited to the terms of Section 6.3.

ARTICLE 8 NO WARRANTY

Licensor makes no warranty or representation whatsoever, express or implied, regarding the validity or enforceability of the IANA Intellectual Property. Licensor undertakes no obligation to Licensee hereunder to maintain, police or enforce the IANA Intellectual Property against any third party-However, if Licensor fails to (a) timely renew any trademark registration for the Licensed Marks or any domain name registration for the Licensed Domains or (b) cooperate with Licensee in any enforcement proceeding except as set forth in Article 4.3, then the specific Licensed Mark or Licensed Domain that Licensor failed to renew or enforce, and all goodwill therein, shall be immediately assigned to Licensee, and Licensor hereby appoints Licensee with full and complete authority and power of attorney to act in the stead of Licensor and to execute and record as Licensor's attorney-in-fact such transfer documentation. Furthermore, if (i) Licensor makes an assignment for the benefit of creditors or similar act, (ii) proceedings are instituted by or against Licensor under any bankruptcy, insolvency, reorganization or other laws relating to the relief of debtors, or (iii) Licensor files for protection under the United States Bankruptcy Code or a foreign equivalent or liquidates, dissolves or otherwise discontinues its operations, then the entirety of the Licensed Marks, and all goodwill therein, and the Licensed Domains shall be immediately assigned to Licensee, and Licensor hereby appoints Licensee with full and complete authority and power of attorney to act in the stead of Licensor and to execute and record as Licensor's attorney-in-fact such transfer documentation. Upon any assignment of the IANA Intellectual Property to Licensee pursuant to this Article 8, Licensee shall engage in discussions with the Operational Communities concerning administration and maintenance of such IANA Intellectual Property.at Section 4.3.

ARTICLE 9 GENERAL PROVISIONS

9.1 <u>Disputes</u>. This Agreement will be governed by and construed in accordance with the laws of the State of California, USA, excluding its conflicts of law provisions. Except to the extent provided in Article 7 above, the Parties irrevocably submit to the exclusive jurisdiction of the state and federal courts sitting in the U.S. District for the Central District of California for the resolution

of all disputes concerning the interpretation, enforcement, breach and termination of this Agreement.

9.2 <u>Notices</u>. Any notice or report required or permitted to be given or made under this Agreement by a Party hereto to any other Party shall be given by registered mail or overnight courier (return receipt requested), to the Parties at the addresses indicated below, and shall be effective upon the earlier of the date of actual receipt by the addressee or the date three (3) days after the same was posted or sent. The Parties shall consult and use reasonable efforts to agree upon a valid and enforceable provision that shall be a reasonable substitute for such Severed Clause in light of the intent of this Agreement.

9.4 <u>Headings</u>. The subject headings of the Articles and Sections of this Agreement are included for purposes of convenience only, and shall not affect the construction or interpretation of any of its provisions.

9.5 <u>Entire Agreement; Amendment</u>. This Agreement and all the Exhibits hereto contain the entire understanding of the Parties with respect to the matters contained herein and supersede any previous agreements (oral, written or otherwise) and may be altered or amended only by a written instrument duly executed by the Parties hereto.

9.6 <u>Assignment.</u> This Agreement is binding upon and shall inure to the benefit of the successors and permitted assigns of the Parties hereto. This Agreement, in whole or in part, shall not be assignable by any Party hereto to any third party without the prior written consent of the other which shall not be unreasonably withheld, conditioned or delayed.

9.7 <u>Sublicensing</u>. The licenses granted in Sections 2.1 and 3.1 above are sublicensable, subject to the prior written consent of Licensor, not to be unreasonably withheld, conditioned or delayed, and provided that: (i) the sublicensee agrees in writing to be bound by the terms and conditions of this Agreement, and (ii) Licensee shall be and remain liable for all actions of the sublicensee in relation to the sublicense, to the same extent as if the actions were those of Licensee. The failure of a Party in any one or more instances to insist upon strict performance of any of the terms and conditions of this Agreement shall not constitute a waiver or relinquishment, to any extent, of the right to assert or rely upon any such terms or conditions on any future occasion.

9.9 <u>Independent Contractors</u>. The Parties hereto are independent contractors. No Party is, or will be deemed to be, the partner or legal representative or agent of the other Party, nor shall any Party have the right or authority to assume, create, or incur any third party liability or obligation of any kind, express or implied, against or in the name of or on behalf of another except as expressly set forth in this Agreement.

9.10 <u>Publicity</u>. No Party shall make any public announcement, press release or disclosure of the terms of this Agreement without the prior written consent of each other party hereto.

9.119.10 <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be an original and all of which shall constitute together the same document.

9.<u>1211</u> <u>Construction</u>. Unless the context of this Agreement otherwise requires: (a) words of any gender include each other gender; (b) words using the singular or plural number also include the plural or singular number, respectively; (c) the terms "hereof," "herein," "hereby" and derivative or similar words refer to this entire Agreement; (d) the terms "Article," "Section," or "Exhibit" refer to the specified Article, Section, or Exhibit of this Agreement; (e) the term "or" has, except where otherwise indicated, the inclusive meaning represented by the phrase "and/or"; and (f) the term "including" or "includes" means "including without limitation" or "includes without limitation" so as to not limit the generality of the preceding term. Unless otherwise stated, references to days shall mean calendar days.

9.1312 Exclusion of Certain Damages. NO PARTY SHALL BE LIABLE HEREUNDER FOR ANY CONSEQUENTIAL, INCIDENTAL, EXEMPLARY, PUNITIVE OR OTHER INDIRECT DAMAGES TO ANY OTHER PARTY OR TO ANY THIRD PARTY OR ENTITY SUFFERED BY THAT PARTY OR ANY OTHER PERSON OR ENTITY RESULTING FROM ANY CAUSE UNDER THIS AGREEMENT, EVEN IF FORESEEABLE.

9.4413 Enforcement of the Agreement. The Parties agree that irreparable damage would occur in the event that any of the provisions of this Agreement were not performed in accordance with their specific terms or were otherwise breached. It is accordingly agreed that the Parties shall be entitled to an injunction or injunctions to prevent breaches of this Agreement and to enforce specifically the terms and provisions of this Agreement in addition to any other remedy to which they are entitled at law or in equity. A Party's pursuit of specific performance at any time will not be deemed an election of remedies or waiver of the right to pursue any other right or remedy to which such Party

For the avoidance of doubt, Licensee's use of the IANA Intellectual Property for any purpose, or in any manner, that is beyond the scope of the licenses granted under Sections 2.1 and 3.1 hereof shall be considered to fall outside the scope of this Agreement, and Licensor shall be entitled to bring any action or seek any remedy available at law or equity (other than the termination of this Agreement or any other Community License Agreement) with respect to such use without complying with the escalation or dispute resolution provisions of Article 7, and without regard to any limitations of liability or exclusion of damages contained herein.
