Steve DelBianco:when you say SEE LIST, we should look for blue highlights in the other doc, right? Steve DelBianco:you say "where ccNSO Guidelines apply" but you're really just saying "where ccNSO guidelines may be helpful"

Maxim Alzoba:Hello All

Heather Forrest:hello Maxim

Steve DelBianco (BC):I recommend we start with an EASY one.

Julie Hedlund::-) Steve

Steve DelBianco (BC):ccNSO really went deep on this. They have 18 pages on "Guideline: ccNSO Procedure for the Exercise of the Empowered Community's rights to Reject Specified Actions" Sara Bockey:Yes, it seems like they were pretty thorough

Steve DelBianco (BC):We (GNSO) relied heavily on the exiting procedures for Council motions Wolf-Ulrich Knoben:Steve, I agree. Why shouldn't we continue as we did with our procedures? Maxim Alzoba:having texts would be useful

Julie Hedlund: I was making it more complicated than it needed to be Heather:-)

Heather Forrest: You added an extra work point!

Julie Hedlund: I'll make sure it's removed ;-)

Heather Forrest:Stephen Deerhake serves as communicator on behalf of the members of the EC - when something needs to be communicated, he does this on behalf of the various SO/ACs

Steve DelBianco (BC): "Nomination process" was one where we (GNSO Bylaws Drafting Team) relied heavily on existing GNSO Council process

Heather Forrest:That makes sense, Steve - working with what we have

Steve DelBianco (BC):in other words, Council has rules around introducing motions, and we have rules on voting thresholds for non-Policy matters.

Steve DelBianco (BC):An example would be helpful at this point of discussion. Please go to a relatively easy item we can walk through. Please

Heather Forrest:@Steve - can we hold off for the moment? I just want to finish with noting what points we have input from ccNSO on, and which not

Heather Forrest: then we'll shift into substance and examples

Steve DelBianco (BC):GNSO has split voting by house. ccNSO does not

Maxim Alzoba: also there is a lack of obligatory policies in ccNSO

Julie Hedlund: That's correct Heather.

Heather Forrest:Busy workload is the most logical reason - thanks David

Steve DelBianco (BC):can't seem to get my mic to work

Steve DelBianco (BC):Just wanted to dive into an item, so we can understand things in practical way

Steve DelBianco (BC):so we should all scroll to 4.3 in adobe

Julie Hedlund:+1 Steve --- that is the staff's sense of the approach.

Julie Hedlund: Either as just a motion or a motion with guidelines

Julie Hedlund: Not changes in the procedures

Julie Hedlund: Per that last paragraph, that may not be necessary per the DT.

Steve DelBianco (BC):David -- Community IRP is end of this doc. Separate

Maxim Alzoba:some kind of collision could happen in GNSO Council

Steve DelBianco (BC):not at all, David

Julie Hedlund:It's an imporant point David and you'll note that the Bylaws DT did identify these as two separate items.

Steve DelBianco (BC):YOU are the IRP expert.

David McAuley (RySG):IRP keeps me busy at times

Julie Hedlund: It is noted elsewhere and in the Operating Procedures

Julie Hedlund: It was a change to the Operating Procedures

Wolf-Ulrich Knoben:it took us several months on council to fix the deferral issue

Heather Forrest: Excellent, Julie!

Steve DelBianco (BC): Julie -- can you please display an example of a GNSO Council motion template?

Heather Forrest:we don't have them

Heather Forrest:!!

David McAuley (RySG): I never have either, seen such a template

Maxim Alzoba:header: motion ... random text inside:)

David McAuley (RySG): like it Maxim

Maxim Alzoba: items not contradicting Operational Procedures

David McAuley (RySG):to mae it part of the motion means it won't be overlooked - always good to consider a 'lower court'

Steve DelBianco (BC):Agree, Julie. Template could note considerations that should be part of the motion language

David McAuley (RySG):make not 'mae'

Julie Hedlund: Yes, that's right Heather and with additional guidelines as needed.
