Thomas Rickert (ISPCP):Hi all, sorry for being late!

Kurt Pritz:The EPDP Team has discussed ways to ensure that the legal compliance work is conducted in a cost-efficient manner. An approach that we think is worthwhile considering is to use the same independent outside counsel for both the EPDP Team and ICANN Org.

Thomas Rickert (ISPCP):Hi Kurt, I ahve sent it to the whole team

Kurt Pritz:We trust that both ICANN Org and our team will need answers to the same questions.

Therefore, reaching out to one firm helps avoid duplicate cost and also potentially conflicting advice.

Berry Cobb:Yes, final approval does occur with the PCST. As noted on the last call, budget has been committed within the EPDP for possible external counsel. The focus now is refining the questions needing legal counsel, requirements + scope, and possible qualifications.

Kurt Pritz:Since we are working on a solution that is fair to all parties facing compliance challenges, we do think that using an independent firm can help to find a balanced solution in which burdens and risks as well as benefits are appropriately shared.

Thomas Rickert (ISPCP) 2:I guess I would like to see what firms are being proposed

Tatiana Tropina:+1 to Thomas

Berry Cobb:Note, Kristina just sent to the list a possible modification to Question #2 that we'll get to later in our agenda.

Leon Sanchez: Where would the proposals come from Thomas?

Thomas Rickert (ISPCP) 2:BTW - I think that what Hamilton wrote was legally solid, although it may not have been results that everyone agreed to.

Thomas Rickert (ISPCP) 2:Hi Leon, I think everyone is free to suggest firms...

Leon Sanchez: Good. Thanks

Marika Konings:In addition to Hamilton, WSGR was engaged for the RDS PDP WG, while Bird & Bird addressed a number of questions in relation to Thick Whois and transfer of data.

Marika Konings:If helpful, staff can pull this information together onto one wiki page so everyone has it handy?

Diane Plaut: Agreed, Margie - it would be essential that the firms would have to identify engagement by any of the parties involved

Diane Plaut: I am trying to get Ropes & Gray to consider being part of the proceurment process as a potential hire

Emily Taylor:Sounds sensible, Kurt

Thomas Rickert (ISPCP) 2:You are right, Kurt. We should use plain language as much as we can. The questions (and answers) might not only be read by us, but also by supervisory authorities at some point in proceedings.

Emily Taylor: I am a bit worried, though, that we are going to get very little concrete guidance from external lawyers on these questions.

Thomas Rickert (ISPCP) 2:@Emily - you might be right.

Emily Taylor:It's all going to be 'it depends'. How useful can this be for the group or the community?

Thomas Rickert (ISPCP) 2:Lawyers are often evasive :-) - excluding colleagues on this team :-)

Tatiana Tropina: Maybe we can have small teams emails exchanges/calls?

Diane Plaut:Yes, sure

Leon Sanchez: I would be happy to go down that path
