Important Note: The scope of protection that the WG recommended for the various Scope 1 and Scope 2 identifiers are not identical. Where some were recommended for top-level protection (e.g. as Strings Ineligible for Delegation, others were recommended for second-level protection (e.g. through entry into the Trademark Clearinghouse and eligibility for a 90-days claims notification process).
