For instance, ICANN's Brussels office is bound by Belgian and EU law in regard to employment, benefits, workplace safety, etc., etc. Therefore, the construction we're looking at makes more sense and is more able to take such situations into account where a particular legal system has rules that result in the application of their laws to ICANN.
