#### **Action Item 4 Task Description, Suggested Approach, and Resource List**

**Task:** Review the ICANN community participation and expertise currently present in the RDS PDP WG and recommend whether additional outreach may be needed.

#### **Suggested Approach:**

- 1) List the diverse perspectives and areas of expertise needed by the RDS PDP WG to achieve Phase 1 goals.
- 2) Review this list against current WG membership to identify any apparent gaps which may include review of SOIs for further details.
- 3) Recommend how those gaps might be filled (e.g., outreach to specific Observers or ICANN SO/ACs).
- 4) Present findings and recommendations to the full WG during the WG's 16 &/or 23 February call.
