Julie Hedlund:Hello everyone and welcome!

Mary Wong:We are also asking this question now as it's possible the document will not be finalized by 22 January, so we want to be sure the Sub Team understands.

Mary Wong:As you may have seen, we have also asked the full WG for vendor suggestions - but that doesn't mean only those potential vendors identified will be contacted. The RFP will be published and anyone can respond.

Mary Wong:@Kristine, yes - it was what was submitted to the GNSO Council.

Mary Wong:Ariel will explain what else is included in the RFP documents (she has her hand up)

Kathy Kleiman:How do we go back to the original data subteam questions?

Kristine Dorrain - Amazon Registry Services:Those are the "charter questions"

Kristine Dorrain - Amazon Registry Services:The original charter questions are stockpiled for later, after we have data.

Kristine Dorrain - Amazon Registry Services:They are the ones that are really biased and unclear, so not very helpful...

Mary Wong:The agreed final Charter questions will be included in the RFP documents

Mary Wong:(as Ariel explained)

Kristine Dorrain - Amazon Registry Services:Yep

J. Scott Evans:I believe you are correct.

Kathy Kleiman:can we have control of the document?

Ariel Liang:unsynced

Ariel Liang:we are currently on page 19 (PDF)

Kurt Pritz:I am for multiple choice questions for two reasons: more likely to be answered, cheaper to analyze the data

J. Scott Evans:Why not eliminate any descriptor and just say "notice"?

Kristine Dorrain - Amazon Registry Services:I think we MUST change the wording to Notice of Registered Names.

Kristine Dorrain - Amazon Registry Services:That's what brand owners get and it's what will ring a bell.

Mary Wong:The Sub Team discussed clarifying when you are referring to Claims Notices (to the potential registrant) and when to a Notice of Registered Name last week.

Kristine Dorrain - Amazon Registry Services:Any other wording may lead to inclusion of "other 3P notices," I think, J. Scott (like any services a brand owner might use)

Susan Payne:thanks Mary - and apologise I haven't caught up yet.

J. Scott Evans:Point taken Kristine

Kristine Dorrain - Amazon Registry Services::)

Rebecca L Tushnet:I would suggest "was it resolved? What was the resolution?" then you don't have to get into satisfaction

Lori Schulman 2:Agree about "if you left it alone."

Mary Wong:Claims Charter Question 3

Kurt Pritz:We are a room full of lawyers (and the survey providers will not be) - it seems we could discuss the choices (cease and desist, etc) in more detail here.

Rebecca L Tushnet:I think we're talking about the NORN that TM owners in TMCH receive, J. Scott

Rebecca L Tushnet:Nevermind, I see what you mean.

Kathy Kleiman:useful, tx!!

Kristine Dorrain - Amazon Registry Services:+1 susan

Mary Wong:If it helps, note that the actual notice received by a trademark owner does use the phrase "notice of registered name".

Mary Wong:To be absolutely accurate, the 2013 TMCH Requirements use the term Claims Notice (for the one that goes to registrants) and Notifications (not notices) of Registered Names (NORN) for the one that goes to TM owners.

Kathy Kleiman:good point

Kristine Dorrain - Amazon Registry Services:I think we should use the full terminology (and a good survey will probably show "click here to see an example")

Kristine Dorrain - Amazon Registry Services:At the risk of impersonating Lori, we should be careful about asking detailed business information and information about specific actions a TM holder took.

Susan Payne:agreed Kristine

Kristine Dorrain - Amazon Registry Services:Agree Kathy

Susan Payne:yes agreed Kathy

Kathy Kleiman:what might you add **or change*... tx!

Kathy Kleiman:agreed
