Lori Schulman:Because of the risk of redundacy.

Lori Schulman: Vendors could potentially charge

Lori Schulman: and we want to keep costs down

Kristine Dorrain (Amazon Registry): Yes, Susan, that's what I meant.

Kristine Dorrain (Amazon Registry): Thanks!

Lori Schulman:INTA members are suffering PTSD from the New gTLD Cost Survey. I am not sure that INTA will agree to distribute.

Lori Schulman: I will have to clear it.

Kristine Dorrain (Amazon Registry): Understandable

Kristine Dorrain (Amazon Registry): Kathy, a little muffled again.

Lori Schulman: I can distribute to Internet and Data Protection Committees. Any other distribution outside of that scope will need INTA executive approval.

Michael R Graham:@Lori -- That would be one approach. Somehow, however, we need to address the "No SME" criticism in our universe.

Lori Schulman: Agree 50+ is not meaningful numbere

Kristine Dorrain (Amazon Registry): A tiny company with 3 brands (and word and design marks) can easily hit 50 registratinos

Michael R Graham:@Kristine -- A good point. Perhaps: 1-10, 11-25; 25-100; 100+? @Lori -- Do we have an INTA TM # model?

Lori Schulman: I would have to look a back at the survey.

Lori Schulman:we grouped by volume of business, I don't recall grouping by portfolio size

Kristine Dorrain (Amazon Registry):@Lori, that's likely smarter

Lori Schulman: Did the AG team look at INTA's report?

Susan Payne 2:I think we should send to other organisations besides INTA. I could send to MARQUES and CITMA internet committees and ask them to socialise. others may be able to do same?

Kristine Dorrain (Amazon Registry): I think we do get into portfolio size when we determine how many sunrise registrations they went for as a percentage of portfolio size.

Lori Schulman: ECTA and ASIPI

Michael R Graham: I would make Trademark Ownership (not outside counsel) a threshhold question.

Kristine Dorrain (Amazon Registry): Agree Susan, we're going to get a hell of an echo chamber going if we don't reach out.

Lori Schulman: and the Asian group.

Kathy Kleiman:good point

Michael R Graham:@Kristine -- Agree to consider further questions for non-recorders.

Kathy Kleiman: Rebecca - what question number would you expand?

Kathy Kleiman:or questions

Kristine Dorrain (Amazon Registry): I like how Susan has taken Greg and Stacey's suggestion to provide a list of suggestions.

Lori Schulman: Again - I believe we segmented on volume of business not size of portfolios

Lori Schulman:portfolios do not always correspond to size of business

Michael R Graham:@Kristine -- Actually, either the TM owner or its Service Providers can provide the TMCH recordation and other numbers easily and quickly.

Kristine Dorrain (Amazon Registry): Agree Lori....

Lori Schulman: I just hung up by accident

Kristine Dorrain (Amazon Registry): Yes, the number of TMs a company has does not correlate to company size AND does not correlate to the number of marks in the TMCH and does not correlate to the number of sunrise registrations they've opted for.

Michael R Graham: @KRistine -- Understood -- I misspoke. But I do think these bands are closer to accurate here -- maybe a bit more. I don't know any companies that are registering in more than a few New gTLDs -- but I can be corrected.

Kristine Dorrain (Amazon Registry): I think a lot of companies registered in most sunrise periods.

Kristine Dorrain (Amazon Registry):But we won't know if our top answer is 50

Kristine Dorrain (Amazon Registry): There should be a 500+

Kristine Dorrain (Amazon Registry): And we should consider if the brandowner will amalgamate them. For one mark, a brand owner might register DNs in 200 sunrises. And for a different mark, might register DNs in 200 different sunrises. So that's two marks, 400 different sunrises.

Kristine Dorrain (Amazon Registry): So what should that brand owner answer?

Kristine Dorrain (Amazon Registry):200 (max DNs for mark 1) or 400 (max DNs total)

Susan Payne 2:I can have a think about this

Michael R Graham:@Kristine -- Agree we need a revised Bands --

Lori Schulman:MM, CSC or Corsearch might have ideas about this. I believe that Corsearch is affiliated with Com Laude.
