from Cyntia King to Everyone: Of course, none of this may matter given GDRP.

from Cyntia King to Everyone: Good point, Susan

from Cyntia King to Everyone: .ECO - what if a scammer listed koch.eco then lost the domain to a ompany that didn't meet reqs?

from Susan Payne to Everyone: agree, but some restricted TLDs don't have pre-registration validation, but do it post-registration. I suspect there would be a better route to challenge it than the URS but it seems at least conceivable there could be a URS

from Susan Payne to Everyone: but if its on auto renewal it shoud continue

from Cyntia King to Everyone: I believe this has been an ongoing question. And that the same registrant could "catch" the expiring domain.

from Susan Payne to Everyone: yep agreed

from Cyntia King to Everyone: Couldn't renewal of offending domain appear to be "bad faith"?

from Susan Payne to Everyone: @Cyntia, but if the registrant has lost then the name is not resolving to the registrants website but to the page that says "this name has been suspended due to the URS"

from Cyntia King to Everyone: + Phil

from Cyntia King to Everyone: I don't see how you get around using full/correct info for arbitration.

from Susan Payne to Everyone: I don't see how they will remain available Phil - you should see this article about what Afilias plans - no contact info published and no access
