Maxim Alzoba (FAITID):Hello all

Maxim Alzoba (FAITID):@Amr , please add to my note about no ability to revoke sunrise registrations that some TLDs like .bank has mechanisms , but it is in the policies of that TLD

Maxim Alzoba (FAITID):demanding , for example that bank still have the license for banking

Amr Elsadr:Thanks Maxim. Noted. Will do.

Amr Elsadr:Email from Susan Payne just now: I'm late to the party but I agree with the definitions, and with including the reference in the agreement so that people can check precise language as required. I also support sticking with the term "reserved names" and not trying to break this down. All reserved names are "contractually allowed", whether they constitute one of the maximum of 100 that the registry can activate for operational or promotional purposes or not. Indeed a number of reserved names are contractually-mandated, either permanently or subject to requirements to obtain consent. I would suggest the important point for these purposes is that names can be reserved, and what the interplay with the RPMs is if names are released from reservation.

Kathy:For question 18 on free expression, fair use (and newly abuse from question 19) :reach out to SO/ACs, Public interest groups and Trade Associations, registrars and registries for information (likely anecdotal evidence)Review of articles, including investigative reporting articles, about the registration of domains in Sunrise Periods that have been noted to have an impact on free expression, fair use, and the ability of registrants to register domain names. Review investigative reporting and collection of their articles about Sunrise and its misuse and abuse; collection of those articles for WG review; possible additional questions for the Reporters, , including misuse and gaming and abuse; questions for Reporters about their research.
