ICANN62 Engagement Session

- Lessons learned for future outreach sessions
- Comments received:
 - **re 4.7**, following a valid WHOIS ARS ticket, or WHOIS inaccuracy complaint, initiate a full audit targeting the relating registrar to check if the registrar follows the contractual obligations, the consensus policies, etc. Sanctions should be applied if deficiencies identified.

“if you have data and proof of systemic issues of a particular registrar and you want to trigger an audit, that's fine. I have absolutely no issue with that whatsoever, and, in fact, i would encourage it, but triggering a full audit of a registrar based on a single complaint is offensive to be perfectly honest. it's overkill. it's a massive waste of resources. it's open to abuse...looking at trends versus picking on single instances, you know, it's something that can be done but you need to be careful how you do it. you need to make sure that you aren't putting a ridiculous burden on one or two actors who actually haven't really done anything wrong as it were”

ICANN62 Engagement Session

- Comments received:
 - **rec 4.3** (slide 32): *not entirely certain, for example, how or why a suspended domain name, because of lack of response from the registrant, should have its information updated without input from that registrant, and what information the working group suggests be put into its place.*
 - **re: 4.8**, *the DAAR blacklist doesn't have any accountability so the subgroup may want to reconsider use of this for compliance purposes*
 - *Contactability was the goal of WHOIS1 and that goal has been accomplished*
 - **Consumer Trust**; *US FTC has some useful information re the role of accessible Whois in protecting consumers (and therefore promoting consumer trust)*
