The RDS-WHOIS2 Review Team undertook the following during this session:

1. Welcome, roll-call, Sol updates

There were no updates to Statements of Interests.

2. Subgroups Status Update

The review team walked through status updates for each subgroup.

Review team members noted that there is overlap between Outreach and Data Accuracy on community education and suggested resolving this overlap during the Face-to-Face Meeting #2.

On **Topic 4 – Consumer Trust**, Erika has distributed draft subgroup report noting document references to consumer trust and expects to conduct a gap analysis after reviewing findings of other subgroups. Alan noted that Topic 4 is heavily impacted by GDPR and may need to be reexamined post-GDPR compliance policy.
