Duane agreed with Russ. A note will be shared via mailing list with RZERC members.

Kaveh also agreed with Duane on suspending the monthly meetings unless there is any action required or request to give feedback or a presentation.

Steve commented on the importance to have at least one in-person meeting for RZERC annually and also asked Duane feedback to use or archive different documentations or discussions about the list of RZERC topics.

Duane agreed with Steve on having at least one yearly meeting during the ICANN AGM in the fall. Duane also mentioned he would like to have these documents as internal discussion records and are valuable just as internal exercise.

Russ suggested to discuss with Staff to keep the recordings of the executive sessions in the archive.
