ORDER IN COUNCIL**MADE UNDER****THE DECLARATION OF TIME ACT****(CHAPTER 280)**

WHEREAS it is provided by section 6 of The Declaration of Time Act (hereinafter referred to as the Act) that it shall be lawful for the Governor in Council by Order in Council on a resolution being passed by the two Houses of the Legislature requesting them to do so, to vary "standard time" as defined by the Act;

AND WHEREAS the two Houses of the Legislature have passed a resolution requesting the Governor in Council to vary standard time as defined by the Act:

NOW THEREFORE in exercise of the powers conferred upon them by section 6 of the Act, His Royal Highness the Governor in Council hereby make the following Order:

1. This Order may be cited as The War Time Order 1942.
2. The standard time for the Colony as declared by the Act shall be varied between midnight on Friday, the 1st day of May, 1942, and midnight on Wednesday, the 30th day of September, 1942, from five hours slow of Greenwich mean time to four hours slow of Greenwich mean time.

WAR TIME.

ORDER IN COUNCIL**MADE UNDER****THE DECLARATION OF TIME ACT****(CHAPTER 280).**

WHEREAS it is provided by section 6 of The Declaration of Time Act (hereinafter referred to as the Act) that it shall be lawful for the Governor in Council by Order in Council on a resolution being passed by the two Houses of the Legislature requesting them to do so, to vary "standard time" as defined by the Act;

AND WHEREAS the two houses of the Legislature have passed a resolution requesting the Governor in Council to vary standard time as defined by the Act:

NOW THEREFORE in exercise of the powers conferred upon them by section 6 of the Act, His Royal Highness the Governor in Council hereby makes the following Order:

1. This Order may be cited as The War Time (No. 2) Order 1942.

2. The standard time for the Colony as declared by the Act shall be varied between midnight on Wednesday, the 30th day of September, 1942, and midnight on Wednesday, the 31st day of March, 1943, from five hours slow of Greenwich mean time to four hours slow of Greenwich mean time.

3. The Company is hereby exempted from the provisions of the Act.

This Order shall remain in force for a period of ten years from the date hereof: Provided however, the Governor in Council may revoke this Order at any time, if the Company fail to comply with and fulfil the terms, conditions and restrictions set forth in the Schedule hereto.

SCHEDULE.

The Company will:

(a) provide the Governor in Council, before it commences operations in the Colony, with substantial financial guarantees that it is able to comply with and fulfil the terms, conditions and restrictions contained in this Order;

(b) for a period of ten years, purchase all products produced within the Colony, subject however, to reasonable conditions as to quality, at a price equivalent to the New York market price at the nearest United States port, less the charges in respect of United States tariff, freight, processing and packing;

(c) provide and establish all machinery and equipment necessary for the preliminary processing of the products;

(d) only use foreign labour in the undertaking if it is impossible to recruit the necessary labour within the Colony;

(e) market the products as Bahamian Products and ensure that the packages and/or containers in which the products are sold to the public in any part of the world bear a label marked "Bahamian Product"; and

(f) establish, within the Colony, an experimental farm of not less than five acres for the purpose of experimenting with and improving the methods of growing and producing the said products and additionally as a means of demonstrating to the indigenous employees of the company the proper methods of growing and producing the products.

2. From the 1st day of February, 1945, the standard time for the Colony as declared by the Act shall be and the same is hereby varied from five hours slow of Greenwich mean time to four hours slow of Greenwich mean time.
3. This Order shall remain in force until the two Houses of the Legislature by Resolution request a return to standard time.

STANDARD TIME.

ORDER IN COUNCIL**MADE UNDER****THE DECLARATION OF TIME ACT****(CHAPTER 280).**

WHEREAS by a Resolution passed by the House of Assembly on the 18th December, 1944, and concurred in by the Honourable the Legislative Council, the Governor in Council was requested to vary the standard time for the Colony as declared by The Declaration of Time Act from five hours slow of Greenwich mean time to four hours slow of Greenwich mean time from the First day of January, 1945, until the two Houses of the Legislature by Resolution request a return to the standard time.

AND WHEREAS by an Order in Council made the 31st day of January, 1945, the standard time for the Colony was varied in accordance with the said Resolution with effect from the 1st day of February, 1945.

AND WHEREAS by a Resolution passed by the House of Assembly and concurred in by the Honourable the Legislative Council on the 15th day of October, 1945, the Governor in Council has been requested to issue an Order in Council returning the Colony to standard time as declared by the said Act.

NOW THEREFORE the Governor in Council hereby orders that the said Order in Council made on the 31st day of January, 1945, shall be and the same is hereby revoked with effect from Midnight on Wednesday, the 17th day of October, 1945.

ORDER BY HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

In exercise of the powers vested in him under section 2 of The Herbert Pemberton Pension Act 1945, and with the advice of the Executive Council, His Excellency the Governor is
