John Jeffrey (ICANN ORG): (13:21) @Thomas -- As you mention in your memo, a joint controller arrangement is only necessary where parties jointly determine the purposes and the means of the processing, i.e. where parties not only cooperate to decide jointly about the purposes but also the means of the processing. Where a party, for example, plays no role in the actual data collection process from registrants, passing registrant data onto the registries, invoicing other activities, in our view, there can be no joint controllership with respect to those processing activities.

John Jeffrey (ICANN ORG): (13:23) but it all depends upon what the agreement looks like because there is no form joint conrroller agreement.. so why the label instead of the work to know the processing roles and activie

John Jeffrey (ICANN ORG): (13:23) activities

Alan Woods (RYSG): (13:24) John, that is not how a Controllership is decided. we have to look to the control exercised, the balance of the parties, the independence of the parties, etc. not just who performs the processing activity.

Diane Plaut (IPC): (13:25) John, it is a factual analysis under the law.

Diane Plaut (IPC): (13:27) Our policy work has set out where the responsibilities lie. We have simulataneously very carefully therefore looked at the factual analysis of the roles and responsibilities.
