#### 2. Update from the Technical Investigator – Casey

Casey presented several slides to provide an update on his work (slides to be added to the wiki). In the past week he analyzed a subset of ASN-to-suffix mappings and was able to find contact information for around 50 ASN-subset mappings. Casey is working with ICANN org to determine the right process for reaching out to these contacts to learn more about their experience as a next step. He has modified the draft form for outreach that would be used to collect further information, as shared last week.
