#### 1. Welcome, roll call

# 2. Current status of the NCAP project; restatement of summary of action items and decisions made from last meeting – Jennifer

Matt provided a high-level overview of the Public Comment <u>responses</u>. The Discussion Group discussed some minor changes, and Anne suggested that more detail should be provided in response to some of the comments from ISPCP and RySG with regard to how the Discussion Group will consider the input moving forward.

Jeff proposed that the comments from RySG in row 20 of the spreadsheet linked above require a discussion about why the Discussion Group should be proposing to do anything different. He suggested that the NCAP Study 2 document should clearly explain why we are proposing something different to the current process. The group had some discussion around this point.

#### 4. Continue discussion on the workflow - Jim

Jim led a discussion on the workflow using the <u>slides</u>, highlighting the areas that had been updated since the previous discussion. He noted areas that the Discussion Group needs to add more detail around, as reflected in the questions in the slides, such as:

- Is it possible to objectively identify a "high risk" label?
- Is it possible to objectively identify "do not apply" labels?
