Matt encouraged the group to review the updated [Board questions](#) document that was shared on the [mailing list](#) 10 January. This version incorporates changes suggested by Anne during the 4 January meeting and via the mailing list. Matt noted that the document is not intended to be set in stone and the Co-Chairs are not seeking consensus at this time. Rather, the Co-Chairs hope that the documents can be seen as in a good place to be moving forward, with the intent that the NCAP work moving forward can be broken down into pieces. Once the Study 2 report finalizes, the Board questions document will be revisited to include cross-referencing to tie the documents together.

Matt noted that the next pieces of work include a discussion with Jeff Schmidt regarding his views on the 2012 round, and sections 1-3 of the Study 2 report. The aim is to share sections 1 and 2 with the group in the coming weeks.
