## 4. Membership survey

- Last year, 2 surveys conducted, addressed to membership
- Sadly, not many responses (8 full answers for one, 8 full answers for the other)
- Some of the highlights, based on which we acted:

## Problems which prevent engagement:

- Cumbersome process, time zone issues, technical challenges, abbreviations
- Lack of broader participation (by members) in collaborative approaches to NPOC tasks, i.e., failure to make ad hoc teams to handle writing, comments, etc.,
- Lack of information reaching us, lack of opportunities to participate in meetings,
- Lack of time for calls, Lack of time for active participation e.g. committee work,
  Insufficient knowledge of the issues and of the policy development process

# Ideas for outreach:

- Bring in the non-profits who are not aware of NPOC and find ways to understand their operational challenges
- Focus on INGOs
- Target NGOs directly
