ICANN74 in The Hague: What to Expect

● Health and Safety

ICANN org is committed to providing as safe a space as possible for in-person attendees. Because of this, ICANN will require attendees to adhere to higher health and safety standards than may be required by local regulations. The following is a general overview of what to expect on site during the meeting.

- All attendees will be required to show proof of being fully vaccinated with up-to-date booster shot(s)
- Daily temperature checks and verbal health screenings
- Contact tracing measures (badge scanning at entries/exits)
- Mask wearing while on-site
- Physical distancing while on-site
- Attendee acknowledgement to agree to health and safety measures

- **Health and Safety (cont'd)**

We will circulate a document after this call containing the points discussed today. More details on health and safety measures for ICANN74 will be published on 31 March 2022 and will be updated as more information becomes available.

- **Event Registration - Mandatory**

Anyone planning to attend ICANN74 in-person will be required to pre-register for the meeting no later than 8 June. This will allow us to allocate our resources effectively.

- **Session Sign-up - Mandatory**

Once the schedule is published on 23 May, session sign-ups will also be required by 8 June to ensure the best utilization of meeting space.

ICANN74: Piloting a Thematic Program Structure (1)

- **How do we maximize opportunities created by the first hybrid meeting since November 2019?**

 - Leverage lessons learned from seven consecutive virtual meetings on how to advance community work

 - Recognize value of coming together to solve problems and have frank discussions

 - Need to prioritize topics and streamline sessions to address Zoom fatigue and maintain volunteer interest and participation

- **What are some important and timely issues that the community can discuss at this time? What topics can reflect progress on the Five Year Strategic Plan?**

 - Subsequent Procedures & the Next gTLD Round: Collaborating on Progress

 - Security Challenges & Technical Developments

- **What is the proposal?**

 - Devote part of the 4-day Policy Forum to 1 or 2 agreed themes/tracks

ICANN74: Piloting a Thematic Program Structure (2)

● **How will it work for each of the two themed days?**

Opening unconflicted community session (possibly facilitated by Board members):

- e.g., what is our progress to date; what are some current issues and major concerns; what could success in addressing them look like?

Each SOAC group can focus on specific issues of interest to them during the day (voluntary)

If appropriate, a closing session to share insights and suggestions (voluntary)

● **What impact will this have on my community's own internal work?**

Not all SOAC groups will be interested in all themes; flexibility and time to get priority work done on other topics to be maintained

Except for one standalone plenary and the geopolitical forum, the other meeting days will not have themes or unconflicted slots

At the end of ICANN74, we will gather feedback on the pilot to gauge community interest in a similar approach for the AGM and future meetings

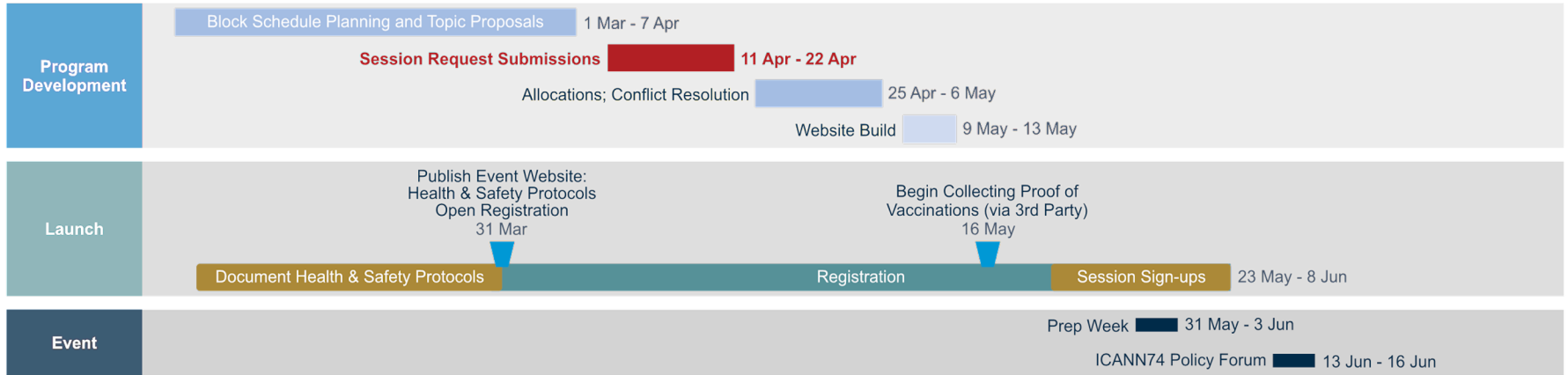
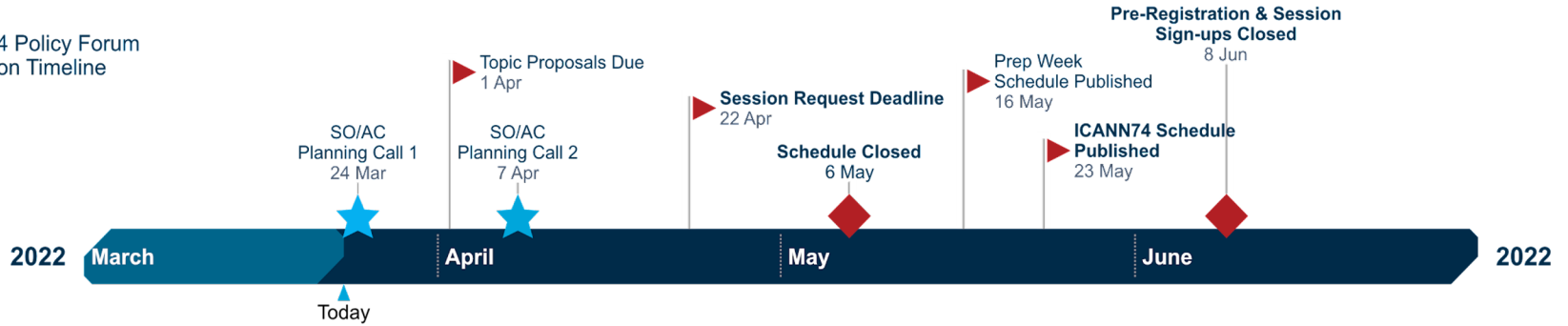
