Re: 30-day Notice of Price Changes effective 02 September 2016

We write pursuant to Article 2.10 – Pricing for Registry Services of the Registry Agreement between ICANN and 21st Century Communications Limited trading as Who's Who Registry to provide ICANN with 30-days' notice of certain price changes.

In a Notice sent to ICANN and dated 01 August 2016, we advised of Price Increases to become effective on 02 September 2016 upon .WhosWho's activation of our tiered pricing model. The changes in the revised Price List (appended) represent only PRICE DECREASES from the 01 August 2016 notice, and we believe do not technically require notice.

These price rollbacks were put in place to remain consistent with those portions of the Tiered Prices that that were noticed to .WhosWho registrars in their original 2014 RRA on a forward-looking basis.

All price reductions described in the 01 August 2016 notice remain in place including the across the board decrease for Standard/untiered names. Standard pricing is dropping to \$20 from \$75 and, in addition, all renewals will now be at the Standard Tier rather than the tier of registration, another drop.

We trust that this will meet with ICANN approval.
