Subject: Cover letter regarding proposed changes to the RRAs for .BOATS, .AUTOS, .HOMES, .YACHTS and .MOTORCYCLES

Dear Carlos,

Dominion Registries is hereby submitting an update to the RRAs for TLDs listed below.

- .BOATS
- .AUTOS
- .HOMES
- .YACHTS
- .MOTORCYCLES

The proposed changes are driven by feedback received by Dominion Registries from several Registrars. Redline versions of RRAs are attached that clearly highlight the proposed changes. Below are the major changes in the corresponding RRAs:

- Modified subsections “1.13 – Registered Names” and “1.16 – Registry Agreement” under section 1 “Definitions”.
- Modified section 2.3.1 “Distribution of EPP, APIs and Software”
- Modified section 2.3.2.1 “Grant” to authorize registrars to invoke additional operations.
- Modified section 2.4 “Changes to System” with corresponding notice duration.
- Added section 2.9 “Unavailable Domain Names”
- Added section 3.5 “Registrant Eligibility Verification” with corresponding subsections 3.5.1 to 3.5.3 (**This section is not added in .Boats RRA as Registrant Verification process was removed in Feb 2018**)
- Added section 3.8 “Indemnification Required of Registered Name holders” (**This is Section 3.7 in .Boats RRA**)
- Modified section 3.9 “Data Submission Requirements” (**This is Section 3.8 in .Boats RRA**)
- Modified section 3.10 “Security” (**This is Section 3.9 in .Boats RRA**)
- Added section 3.15 “Additional Requirements for Registration Agreement” with corresponding subsections 3.15.1 to 3.15.5 (**This is Section 3.14 in .Boats RRA**)
- Modified section 3.22 “Registrar’s Resellers” (**This is section 3.21 in .Boats RRA**)
- Added section 3.26 “URS” and corresponding subsections 3.26.1 , 3.26.2 and 3.26.3 (**This is section 3.25 in .Boats RRA**)
- Modified section 4.1 “Amount of Dominion Registries Fees” and added subsections – 4.1.1, 4.1.1.1 and 4.1.1.2
- Added section 6.1.2 “Indemnification by Dominion Registries”
- Modified section 6.2 “ Limitation of Liability”

- Added section 6.3 “Reservation of Rights”
- Added section 8.2.6 under section 8.2 “Termination”
- Added section 8.3.4 under section 8.3 “Effects of Termination”
- Modified section 8.4 “Survival” with correct sections to survive in the event of termination of agreement.
- Modified subsections 9.3.1, 9.3.3 and 9.3.5 under section “Representations and Warranties”
- Modified section 9.3.3 “Disclaimer of Warranties”
- Exhibit E – Modified information related to Registration/Renewal fees
 - Reduced standard domain registration & renewal prices to \$25 USD for all TLDs except .Autos
 - Reduced premium renewal prices to \$25 USD for all TLDs except .Autos
 - New reduced prices for .Homes TLD will be effective from 01/14/2019 16:00 UTC

Please note in addition to above major changes, there are also some minor cosmetic changes done to all RRAs. Such changes are also redlined.
