RE: Registry-Registrar Agreement Proposed Amendments (.gay, .health .ink, .tattoo, .wiki)

Dear ICANN,

Pursuant to clause 2.9(a) of the Registry Agreements executed between ICANN and Registry Services, LLC, we submit the below-described changes to our Registry-Registrar Agreement.

We respectfully request prompt review in accordance with the Registry-Registrar Agreement (RRA) Amendment Procedure. In compliance with the procedure, we attach a 'redline' version showing the proposed changes to the current form of Registry-Registrar Agreement.

The changes proposed are for the purposes of streamlining and consolidating our Registry-Registrar Agreements following the recent acquisition of a number of TLDs. The changes to the Registry-Registrar Agreements are also described in the table below.
